Development Committee Report for May 18, 2017 Board Meeting

Goals & Purpose of Committee

PURPOSE (per 6/28/11 Resolution): "Identify and solicit donations from individuals and entities, the latter including businesses, foundations, other charitable organizations, and any other potential donor; and identify and solicit in-kind support from potential donors to further the Purpose of the Corporation"

GOALS for FY 2016-17:

Achieve Budget Line 1100 cumulative amount of \$370,000 Expand number of Event Sponsors (minimum donation of \$25K) Implement measures to engage MAR members and event attendees for personal donations Expand the base of business donors

Old Business

► The donation kiosks at the 2017 events were well received, culminating with considerable success at the District Championship. Cumulative donations exceeded slightly the objective of \$7K. The student volunteers were extremely supportive.

► For the Direct Marketing test campaign to expand our corporate donor base, we have paid \$260 for a list of 1,000 confirmed names and addresses – designated by SIC codes. The content for the mailings was decided during the Committee's April meeting. An invoice for \$863 needs to be paid for the fulfillment work after which the campaign will be rolled out.

► Efforts continue to provide our J & J liaison the requisite information by which to substantiate a generous donation for this fiscal year.
